THE EFFECT OF THE CORRECTION WAS A \$342,965 DECREASE IN BEGINNING BENEFICIAL INTEREST IN THE ASSETS OF BENTON COMMUNITY FOUNDATION AND NET ASSETS WITH DONOR RESTRICTIONS AS OF JULY 1, 2023. ADDITIONALLY, THE CENTER IDENTIFIED A GRANT IN THE AMOUNT OF \$53,800 THAT SHOULD HAVE BEEN RECORDED AS PART OF REVENUE FOR THE YEAR ENDED JUNE 30, 2023; THE BEGINNING NET ASSETS HAVE BEEN RESTATED ACCORDINGLY.
